Pet Travel between Great Britain and Ireland

The UK's departure from the EU has resulted in a change in the rules for pet travel between Ireland and the UK. The rules for travel to and from Northern Ireland have not changed.

Pets travelling from GB to Ireland must be;

1. Microchipped before the rabies vaccination is administered (Pets may be tattooed instead of microchipped, only if tattoo applied before 3rd July 2011);
2. Vaccinated against rabies by a vet

Since 1st January, 2021, in addition to the above requirements, each pet travelling, or returning, from GB to Ireland;

1. May only enter Ireland through certain Travellers' Points of Entry: Dublin Airport, Rosslare Port, Port of Cork at Ringaskiddy, Shannon Airport and Cork Airport, and Dublin Port.
2. Must travel with either a health certificate issued by a UK official vet or an EU pet passport.

Note! EU pet passports issued by Northern Ireland will remain valid if they have been marked with a sticker by the issuing vet in Northern Ireland. If required, contact your local issuing vet in Northern Ireland for information.

An EU pet passport that was issued in GB will not be valid for travel to the EU, even it was issued before January 2021. Pet owners are advised to retain any GB issued EU pet passport, as it may contain important information about vaccinations, treatments, etc. This passport and animal health certificate should accompany the pet during travel from GB to Ireland.

3. Dogs travelling from, or returning from, GB to Ireland will require treatment against Tapeworm by a veterinarian 24 to 120 hours (1 to 5 days) before arrival in Ireland. If travelling with a passport issued in Ireland, this treatment may be entered into the pet passport by a UK vet. If the pet does not have an EU pet passport, the pet must be accompanied into Ireland by a health certificate issued by the UK authorities. A health certificate is required before each entry into the EU. Pet owners should contact the UK authorities for information on how to apply for this health certificate.

Banking in Ireland

With more and more services and Government agencies signposting customers online or using centralised call centres to 'field' calls from clients and the public, it can often be very difficult and stressful to find the answers to queries or deal with stressful situations that life can present us all with from time to time.

We are heartened to learn that the larger Irish banks now offer dedicated support phone lines for older and vulnerable customers. Bereavement Support teams are also available, as are sections specifically tailored to people who may be returning/coming to live in Ireland. To find out more, drop into your local branch or go online to the relevant bank and search under whichever of the above services you are seeking. Frequently Asked Questions – Health care in Ireland

I am an Irish citizen and will be moving back to Ireland shortly. I have been told that I will need to be 'ordinarily resident' in order to access health care in Ireland. I am not sure what this term means.

Q. Can you please clarify that for me?

A. The term 'ordinarily resident' in relation to accessing health care in the public system in Ireland means you must satisfy the Health Service Executive (HSE) **that you have been living in Ireland for at least a year OR you intend to live here for at least one year.**

To establish that a person is ordinarily resident the HSE may require back up evidence, some examples;

- Proof of property purchase or rental, including evidence that the property is the person's principal residence (for example, proof of rent from the local authority)
- A letter or statement from a financial institution (for example a bank statement or credit union statement)
- A current utility bill (such as a gas, electricity or phone bill)
- A current car or home insurance policy in your name
- An official document from a government department (for example, a notice of assessment from Revenue or proof of rent from the Housing Assistance Payment Scheme)

Note! The above documents must be dated within the last 12 months.

I don't think that I will qualify for a Medical Card under the income/means testing guidelines when I move back to Ireland.

Q. Does this mean that I will not be able to access any health services?

A. Even without a full Medical Card, once someone is considered 'ordinarily resident' in the State, they can avail of health care within the public system, albeit in a more limited capacity.

Depending on circumstances and in some cases, age, there are a range of schemes /other avenues that may be applicable, in summary;

GP visit card – This card allows the holder to visit their GP for free. The allowable income levels to qualify for the GP visit card are higher than for the Medical Card. If you are turned down for a Medical Card on the basis of income, you could still qualify for the GP visit card. **Note!** there is free GP care for everyone over 70 years of age, regardless of their income. Free GP care also applies to children under 6yrs; this is expected to be expanded shortly, to include children aged 6 and 7rs.

Long Term Illness Scheme – If you do not have a Medical Card but suffer from certain medical conditions/disabilities, you may qualify for a Long Term Illness Card, regardless of your income. The card will cover the treatment and drugs relating to the specific condition that is approved under the scheme.

Drugs Payment Scheme (DPS) – Under this scheme, regardless of income, an individual or family will pay no more than €80 each calendar month for:
approved prescribed drugs and medicines
rental costs for a continuous positive airway pressure (CPAP) machine or rental costs for oxygen

Medical Card under EU regulations – If you move to Ireland and are in receipt of an EU State Pension and are not in receipt of any pension /income from the Irish State, and are not employed or self-employed here, you can qualify for a Medical Card, regardless of your income.

Important Note! Although Britain has left the EU, the UK State Pension is still accepted as a 'qualifying payment' under this scheme, due to pre-existing Common Travel Area arrangements.

What is a JAM Card and who can use one?

JAM Card allows people with a learning difficulty, autism or communication barrier tell others they need 'Just A Minute' discreetly and easily.

Those with a communication barrier are often reluctant or unable to tell others about their condition. JAM Card allows this to happen in a simple, effective non-verbal manner. JAM Card was originally developed for those with learning disabilities and difficulties. However, it can be used by anyone with a communication barrier.

For instance, JAM Card can be used by people with Asperger's or autism. It can also be used by those who have a brain injury and people who otherwise feel self-conscious about their ability to effectively communicate when engaging with others.

Many of the larger Irish retailers and some of the transport providers (Bus Eireann, Irish rail, Dublin Bus) are now JAM Card friendly. For more information or to request a JAM Card, please visit;
