Application for Social Housing in Ireland and Income Limits

Councils here in Ireland will only process non-resident applications from qualifying Irish emigrants, under the scheme, facilitated by ourselves here at Safe Home Ireland.

Generally, the Council approval will only relate to Housing Association schemes for older people, rather than the broader approval to cover all types of social housing supports - this includes access to Council housing/Housing Association properties and help with rent costs if renting from a private landlord under the Housing Assistance Payment scheme.

Social housing applicants must meet income /means testing guidelines as well as meeting the set criteria for the provision of housing for older Irish emigrants (outlined below);

Safe Home Ireland housing applicants must be;

- Older Irish born emigrants, aged 57yrs+
- Living in rented accommodation abroad
- Unable to provide accommodation for themselves from their own means
- Capable of independent living.

Remember! Even if you do not meet the criteria to apply for housing under our scheme or have accommodation sourced for yourself on return, you can still link in with us for information on returning/moving to Ireland or if you need to avail of some outreach support, to help you get 'into the system' here on return.

Social Housing Means Testing; The [Household Means Policy](#) provides details of how your household income is assessed by local authorities for social housing support. The Policy includes information about what income is taken into account and what income is disregarded (not taken into account). For example, certain social welfare payments are not considered in these assessments.

There are 3 maximum income limits that apply to different housing authorities. You can find out more about the allowable income limits [HERE](#).

The local authority looks at the household's average net income for the 12 months before they received your application when assessing if your household meets the income criteria. Net income is the amount you are left with after tax and other deductions.

*From 1st. of October 2022. the maximum income limit for a single person increased in some



For those affected who may be living overseas; supports have been put in place through some of the Irish advice and welfare services in Britain and the USA, Embassy staff in other areas may also be able to provide guidance.

I am living in the UK and wish to apply for my Irish passport. My driver's licence is out of date.

Q. Can you advise what other type of photo ID may be acceptable.

A. The Passport Office confirmed the following, "If a person does not have photo ID they would need to obtain some, this requirement for first time applications cannot be waived. This could include a passport from another country, a driving licence, or a national ID card. From the UK we may also accept an electoral card".

Contacting the Passport Office

Paper applications are still accepted but take significantly longer than online applications. The Passport Office advises where at all possible, applications should be made online [HERE](#)

Online applications are handled centrally by the Passport office in Ireland and not in the Passport Offices/Embassies abroad.

All queries relating to online applications are handled by the Customer Service Hub in Dublin, through the [webchat](#) service or by phone at **+353 1 671 1633**, which is available between 09.00-16.30 Monday to Friday.
