Government of Ireland Emigrant Support Program

Welcome to our December Newsletter! As 2024 draws to a close, I'd like to take time to reflect on the incredible year we have had. It was a busy but impactful year and I am excited to share a few of the highlights and achievements that have helped shape our success this year.

January marked the second anniversary of Friends of Safe Home Ireland, a group who have done so much to support and promote Safe Home Ireland and introduce us to many new partners, donors and supporters. We are grateful to all the members, who prefer to work quietly behind the scenes, but whose impact is felt far and wide. Their dedication and generosity enable us to continue our vital work, and we look forward to continued collaboration again in 2025.

In **March**, we were pleased to launch our new Strategic Plan and host a Social Inclusion Seminar in partnership with The Irish Centre for Social Gerontology and the Institute for Lifecourse and Society (ILAS) at the University of Galway. Our Strategic Plan sets out our vision and strategic direction for the next five years, reflecting the evolving nature of our work in responding to the needs of the Irish diaspora.

In May we walked The National Famine Way for our second year from EPIC The Irish Emigration Museum, Dublin to The National Famine Museum | Strokestown Park Co. Roscommon. We were also pleased to join the National Famine Way Commemorative Walk in May and walk with former The Irish Ambassador to Canada, Eammon McKee, members of The Liverpool Irish Festival Famine Trail and Carollin Callery, of the National Famine Way. The partnerships highlight the significance of this trail and broadens the conversation about the ongoing impact of emigration on Ireland, both historically and in the present day. We look forward to doing this walk again in May 2025 (dates tbc).

A key highlight of the year was my **outreach trip to the US** in **September** and to visit the cities of New York, Boston and Philadelphia. This was a unique opportunity for me to connect with Irish diaspora, some of whom are making progress to return/move home to Ireland and to meet with so many incredible Irish organisations there. I was blown away by the welcome and hospitality and to witness first-hand the work that is been done to support and engage with our diaspora. Our last outreach to US was in 2005 so this was a long awaited visit!

In **October**, Seán Fleming, TD and Minister of State Department of Foreign Affairs launched our recently established Returned Emigrants Network (REN). The Network meets bi-monthly in Portlaoise, Co. Laois as well as virtually. It is intended to act as a social hub to promote wellbeing, a chance for returnees to meet and support each other, especially during the early days of resettlement. We hope to hold meetings in other areas of Ireland in 2025.

In **December**, we were excited to commence Safe Home first European (Erasmus+) project in partnership with not-for-profit organisations in Germany, Spain, Belgium and with our colleagues here in Ireland, <u>Crosscare Irish Diaspora Support Project.</u> The project aims to empower organisations facilitate intra-European mobility and diaspora groups to enable learners to identify policies/resources, develop best practices, networking and to promote inclusion.

We continue to meet regularly with our partners here in Ireland, Crosscare Irish Diaspora Support Project, Citizens Information and Irish Council for Prisoners Overseas (ICPO) to ensure we work together to offer a co-ordinated and seamless service to the Irish diaspora and those who are considering or have returned home to Ireland. This year we also worked in partnership with Irish Embassies and Consular Services to support, guide and directly assist those who required our support to return home.

We wish you all a safe, healthy and peaceful holiday season; we know Christmas can be a challenging time for many people so look out for each other and check in on those who are alone or lonely at this time of the year.

# Exciting news! Safe Home Ireland receives support from Jim Callery's 90th birthday fundraising walk on National Famine Way

We are delighted and honoured to announce that Safe Home Ireland is one of the four charities selected to receive the proceeds from Jim Callery's extraordinary fundraising walk to celebrate his 90th birthday. In October 2024, Jim, the founder of <u>The National Famine Museum</u> <u>Strokestown Park</u>, Co. Roscommon, walked The National Famine Way (165km) from Strokestown Park, to <u>EPIC The Irish Emigration Museum</u> in Dublin.. Through his remarkable effort, Jim raised an impressive **€165,200**, which equated to just over €1,000 euro for every kilometre he walked.

We are deeply grateful and humbled to be standing alongside three other outstanding charities; The Capuchin Day Centre (Dublin); New Horizons Refugee & Asylum Seeker Support Group (Athlone); Schools of Sanctuary Ireland. Each of these organisations does vital work, and we are proud to be part of this group.

On **Wednesday, 11th December, Ann Roddy** (our Company Secretary) and **Johnny B. Broderick** (Information and Communications Officer) were honoured to attend a cheque presentation at Strokestown Park. Speaking at the cheque presentation event which took place at Strokestown Park House today (Wednesday 11<sup>th</sup> December), Jim Callery said, "My heartfelt thanks to those who donated and to those who came and walked a stretch with me. There were times when it was tough, wet and cold but I thought of our 1,490 famine emigrants and how much tougher it must have been on them and it gave me strength. I thought of current day emigrants and the difficulties of their journeys and focused on the fundraising. Our original target of  $\in$  25,000 was surpassed in less than a week and that I am most grateful. I am very happy to be here today to hand over  $\in$  41,200 cheques to 4 very worthy registered Charities whose work I greatly admire. I am happy that the funds I have raised will be going deep to the roots – to those who need it most".

A sincere thank you to Jim for choosing Safe Home Ireland, to Carolin Callery and the entire Callery family for their unwavering support. We also extend our thanks to Strokestown Park, the Westward Board, and everyone who generously donated to Jim's walk. Donations came from all over Ireland and from the UK, the US, Europe and even Australia - from Jim's friends, family and business associates.

#### **UK Winter Fuel Payment (WFP)**

**The new eligibility criteria** for the Winter Fuel Payment (WFP) came into effect recently for the winter of 2024–2025. These changes include stricter means-testing requirements, which limit eligibility to individuals receiving certain income-related benefits such as Pension Credit, Universal Credit, or other similar benefits.

If you have questions or need further clarification regarding your on-going eligibility or the impact of these changes, you can contact the Winter Fuel Payment Centre at 0800 731 0160 (within the UK).

The changes primarily target recipients in England and Wales. However, previous recipients living abroad, **including in the ROI**, will likely be impacted, as they must meet the new qualifying criteria to continue receiving the payment. This marks a departure from the previous universal approach to the WFP where eligibility was primarily age-based and extended to eligible UK nationals abroad under certain conditions.

Recipients of the Winter Fuel Payment (WFP) resident in the Republic of Ireland (ROI) who previously received this benefit and wish to clarify their current position can contact: The Winter Fuel Payment Centre via:

#### **Fuel Allowance – Ireland**

The Fuel Allowance season normally begins in late September of each year and ends in April. The 2024/2025 Fuel Allowance season started on Monday, 23 September 2024. It will be paid for 28 weeks (until 4 April 2025). The current rate of Fuel Allowance is €33 per week. You can choose to get the Fuel Allowance paid every week or paid in 2 instalments (lump sums). In summary, to qualify for Fuel Allowance, applicants must:

- Live alone (or only with certain qualifying people)
- Be getting a qualifying payment (unless you aged 70 or over)
- Satisfy a means test

#### Changes announced in Budget 2025

- The Fuel Allowance means test disregard for people aged 66 and over will be €524 for a single person and €1,048 for a couple (January 2025).
- Carer's Allowance will become a qualifying payment for Fuel Allowance (January 2025).

If you previously turned down for Fuel Allowance on income grounds or if you meet the new conditions (re Carer's Allowance) to qualify, it would be a good idea to verify your situation by contacting, **The Pension Services Office in Sligo. Tel: (071) 915 7100 or 0818 200 400** 

#### Frequently Asked Question – Social Housing (Council) Applications

I am 66 years old and currently renting a Council flat in Manchester. Over 2 years ago, I applied for housing via the Safe Home Ireland scheme designated towards assisting qualifying Irish emigrants to secure housing back in their native areas. I am happy to say that I did eventually get approved on the Council housing waiting list so that I can be considered for a Housing Association tenancy down the line.

**Qu.** When I filled out the Council form I was allowed to select 3 locations/ areas of choice on my housing form. **Can I change those areas?** 

**A** Applicants must stick to the 3 areas of choice that they initially selected for a period of 12 months. Once the 12 months have elapsed, they can amend their areas. They must notify the relevant Council **in writing** in order to have their housing file updated.

#### Planning a return home / Moving to Ireland – come prepared!

If you are someone who may be making plans or keeping your fingers crossed for a move to Ireland in 2025, it's no harm to start gathering together some bits and pieces that should help to speed things up this side and thus make the transition and resettlement process go a little smoother for you! Please find below some examples of important documents to bring with you, depending on your circumstances.

**Important Note!** Having easy access to a good paper trail of documentary evidence will be particularly relevant to anyone who may need to seek welfare or social supports when they move here.

- Personal documentation birth cert, marriage cert, divorce papers;
- Back up documentation regarding any medical conditions and take home 3-6 month's supply of medication if possible;
- Name and Address of last employer and social security number, latest P60/equivalent, and recent payslips
- If in receipt of a benefit or pension from abroad, the latest annual statement outlining your entitlement;
- Proof to show that any non-transferrable benefits have been stopped;
- Proof property abroad has been sold or a tenancy ended;
- Car insurance documents (that show 'no claims history');
- If taking car drivers licence, documents to show ownership;
- 6 months' bank statements and, if possible, closing statements.

#### Mother & Baby Institutions Payment Scheme – Enhanced Medical Card

#### The enhanced medical card entitles the holder to the following services, without

charge, under the public health system in Ireland:

- GP services;
- prescribed drugs, medicines, aids and appliances;
- dental, ophthalmic (services to help with eye diseases) and aural (hearing)
- services;
- home nursing;
- home support;
- counselling;
- chiropody/podiatry (feet issues); and
- physiotherapy.

In addition, if you have a medical card you do not have to pay the  $\in$ 100 Emergency Department statutory charge.

#### Important Notes!

- If you are already in possession of a means-tested medical card in Ireland, it may still be worthwhile to apply for the enhanced medical card under this Payment Scheme. This is because the enhanced medical card is not means-tested.
- For qualifying applicants who are currently permanently resident outside of Ireland, a health support payment valued at €3,000 is payable, instead of the enhanced medical card.
- In the event that a person in this situation returns to live permanently in Ireland in the future, they can still apply for the Medical Card here in the normal way (i.ie via the means testing process).

## How does the Enhanced Medical Card application process work?

When applications are received under the Payment Scheme, processing staff check the application to assess eligibility for the Enhanced Medical Card. Once approval is determined, the following details are sent from the Payment Scheme office directly to the HSE to action the allocation of the card;

Name, Address, Date of Birth, PPS number

The processing of the Enhanced Card is then solely 'in the hands' of the HSE (Medical Card Section). The medical card contact line is 01 864 7100 / 0818 22 44 78 if you need to contact them.
